

Copyright Policy

The Tazewell County Genealogical & Historical Society (“TCGHS”) recognizes and respects intellectual property rights and is committed to fulfilling our moral and legal obligations with respect to our use of our and others copyright-protected works.

Copyright

Except for material in the public domain under United States copyright law, all material on www.tcghs.org (“Website”) is copyright TCGHS unless otherwise indicated. Materials are only meant for the viewing, research, and personal non-commercial use of the user. Copying or redistribution for commercial gain without permission of TCGHS is prohibited.

The nature of historical archival collections means that copyright or other information about restrictions may be difficult to determine. Whenever possible, TCGHS provides information about copyright owners and other restrictions in the catalog records, finding aids and donor records. TCGHS provides such information as a service to aid researchers in determining the appropriate use of an item, but the legal determination ultimately rests with the user.

Images, footage and other content reproduced from the collections of TCGHS are for viewing, research and personal non-commercial use only. Permission for commercial use or any publication, manipulation, display or distribution must be pre-approved by TCGHS.

All material contained on the Website (including all software and other code) is protected by the United States and foreign copyright laws. Upon receipt of notice complying with the above requirements, TCGHS will act to remove infringing materials and, if applicable, send notice to the user that posted such materials on the Website.

If TCGHS removes materials posted by you as a user due to alleged copyright infringement, you may seek to have the materials reinstated by notifying TCGHS in writing, including the following information:

- Your full name, address, and telephone number
- Your e-mail address
- Identification of the material that has been removed or to which access has been disabled, including its location before it was removed or disabled
- Your statement under penalty of perjury that you have a good-faith belief that the material was removed or disabled as a result of mistake or misidentification of the material
- Your statement consenting to the jurisdiction of the U.S. District Court for the Central District of Illinois (where TCGHS may be found), and that you will accept service of process from the person who provided notice of copyright infringement or from such person's agent
- Your physical or electronic signature

Upon receipt of a notice meeting the above requirements, TCGHS will send a copy of the notice to the copyright owner who initially claimed copyright infringement. Within 14 days following receipt of the notice, TCGHS will replace or enable access to the removed material unless TCGHS receives notice from the copyright owner who submitted the first notification that it has filed an action seeking a court order to restrain the user that posted the materials from engaging in infringing activity.

Please note that parties who misrepresent that materials are infringing or were removed by mistake or misidentification are subject to substantial civil liability to TCGHS and/or the copyright owner or website user.
